

CONDITIONS OF ENTRY

1. In these conditions:" the Federation" shall mean and include the Australian Karate Federation (Qld) Inc., its officers, servants or agents." Opponent" shall mean any person competing against the competitor.
2. In consideration of the Federation accepting my application to enter and compete in the tournament and in further consideration of my opponent competing against me, I hereby agree to abide by the conditions of entry, the rules, by-laws and the regulations of the Federation and directions of referees and tournament officials.
3. The Federation enters into this contract as the Federation and as agent for the competitors opponent.
4. I will do my best to avoid personal injury to my opponent, and understand if any injury is sustained by my competitor I may be held accountable by the AKF Qld rules.
5. I acknowledge and agree that the Federation shall not be liable whether in tort or contract or otherwise for any loss or damage whatsoever to my property whilst participating in or otherwise attending at the tournament, howsoever caused or occurring including without limiting the foregoing, the negligence, breach of contract wilful act or default of the Federation and whether or not such loss or damage to my property occurs within or adjacent to any property occupied by the Federation.
6. I acknowledge and agree that my opponent shall not be liable whether in tort or contract or otherwise for any loss or damage whatsoever to my property whilst participating in or otherwise attending at the tournament, howsoever caused or occurring including without limiting the foregoing, the negligence, breach of contract, wilful act or default of the opponent and whether or not such loss or damage to my property occurs within or adjacent to any property occupied by the Federation.
7. I understand, to be eligible to enter this tournament, I must have personal accident insurance which will cover any injury or illness sustained by myself, or my child (as a competitor), at this tournament. I
8. acknowledge and agree any photographs and or videos of myself (as a competitor) or my child (as a competitor) taken at this tournament by AKF Qld may be used by AKF Qld to promote or advertise AKF Qld.
9. I acknowledge and understand that the sport of Karate is a combative sport, and whilst all care is taken by the instructors, officials, and competitors, to ensure my safety, there is the potential for injury or illness, accidental or otherwise.
10. I acknowledge myself, or my child (as a competitor) has no pre-existing injury or illness that may be exacerbated by competing in this tournament. I understand if I have a pre-existing injury or illness, I must supply a medical clearance form by a qualified medical practitioner to prove I am fit and well enough to compete.
9. I understand I am not eligible for a refund of competition fees after the due date of this tournament.
10. I have read the conditions of entry, understand them and have filled in my form correctly and honestly and as such my signature appears below, for myself (as a competitor), or my child (as a competitor)
11. I hereby confirm that I have read all of the terms and conditions for entry into this tournament run by the AKF Qld.
12. I understand these terms and conditions and know that all rules of the AFK Qld. must be adhered to at all times during the when participating in any activity or event associated with the AKF Qld. I agree that I shall be under the sole direction of the the Team Manager, Coaches, and his/her assistants for the entire duration of training sessions, seminars tournaments, or any other activity associated with the AKF Qld.
